The Chico Unified Teachers Association is awarding scholarship grants to 2010 graduating high school seniors from Chico High School, Fair View High School, and Pleasant Valley High School who are planning to attend universities, colleges, community colleges, or vocational/technical training/schools.

***Please make every effort to observe the following points concerning your application so that you will guarantee your chances to be considered for receiving a scholarship.***

1. **The application due date is 3:30 PM on Friday, April 16, 2010. Applications must be submitted to the Counseling Office secretary at your high school. Please remember that applications submitted after the due date/time cannot be considered.**
2. Type or legibly print in ink when filling in the application, answering all questions as completely as possible.
3. Applications should include an up-to-date transcript and one or two letters of recommendation from a family friend, employer, minister, etc. (Do not use school personnel or family members).
4. The financial page is important. Your need for financial assistance is one of the criteria considered for selection of scholarship recipients and will be determined through this information. Your application is treated as confidential and will be seen only by the CUTA members who are on the selection committee. From the information provided, each student is placed into one of five financial categories: (1) great need; (2) considerable need; (3) moderate need; (4) some need; or (5) little or no need. If no financial information is provided, the student will be placed in the "little or no need" category.

Announcement of recipients will be made at the high school senior awards programs in May.
